WELCOME POST DOCTORAL FELLOW!

The Canadian observatory is pleased to welcome Dr. Steve Sellers and very thrilled about his exciting research topic -- Improving Justice Responses to Intimate Partner Violence: Examining Change in Police Officer Attitudes to Intimate Partner Violence. Located at Griffith University in Brisbane, Australia, the focus of Steve's research is to explore police officers' attitudes about domestic violence and related factors which guide their decision making. Emphasis will be placed on assessing changes in attitudes over time. With two rounds of survey data we will be able to learn how police attitudes towards decision making in domestic violence incidents have changed overtime and to assess the influence of violence training on decision making and police response to victims. Steve joins postdoctoral fellows Cheryl Fraehlich, University of Manitoba, Liz Wells, University of Guelph, and Lanette Ruff, University of New Brunswick.

CANADIAN OBSERVATORY HOLDS DIALOGUE IN OTTAWA

The Canadian observatory will hold a dialogue meeting in Ottawa on May 27, 2010. Entitled "Data collection and data sharing: Moving forward on the justice system response to intimate partner violence" the meeting will bring together Canadian observatory members and federal/provincial/territorial governments from across the country. The purpose of the meeting is to discuss data collection and data sharing, to forge stronger cross-sectoral partnerships, to identify barriers to sharing data across sectors, and to strategize a collaborative cross jurisdictional means to move forward on the justice system's response to intimate partner violence.

CANADIAN OBSERVATORY SELF-REPORT EVALUATION

The Canadian observatory launched a mid-term self-report evaluation in November 2009. Developed in collaboration by Elizabeth Blaney, Sonia Gauthier, Joseph Hornick, and Margaret Jackson, the evaluation tool provides the network with information to help the Canadian observatory to create and maintain processes that reflect and enhance participatory practice. SECOND RESEARCH AGREEMENT SIGNED!

In May 2010, the Canadian observatory signed a research agreement with the Province of New Brunswick. The research agreement will enable us to collect data on offenders who are entering into the justice system in Moncton and Fredericton. Joining with Yukon, the new agreement means that now the Canadian observatory can collect data in three cities (Whitehorse, Fredericton, Moncton). The Canadian observatory is currently working on developing a data warehouse where the information will be stored.

Violence Against Women in Canada: Research and Policy Perspectives examines a wide range of theoretical perspectives, empirical research, and policy responses, emphasizes connections among different forms of violence. Taking a gendered sociological approach, the authors examine how violence against women stems from unequal access to power and resources. The authors also show how intersections of race, ethnicity, class, and sexuality deepen inequalities for particular groups. This new book explores the evolution of methods to measure violence, the impact of these methods on the social framing of violence issues, the impact on victims, and current policy responses and their effectiveness.
